March 12th, 2025

Secretary's Report: Motion was made by John, seconded by David with all in favor.

Old Business:

- 2 Fuel Report: 427gallons used in January
- Bids for social hall renovations was discussed. The supervisors decided that they would paint the social hall themselves. They will decide between Morgan Concrete and Haglee Epoxy after they make some further inquiries about their bids. The other bids were declined due to being much higher in price.

New Business:

- Stone bids were opened and awarded, with Bucktail Excavators be awarded 2A, 1B, 1BW, 2RC, & 3B. JM Delullo Stone Sales was awarded R5, R7, #67, #57.
- CDs were renewed with a slight change. One CD will be a 6 mo and we will change the second to a 9 mo to keep the three CD coming due every three months.
- A question came up during the meeting concerning social hall rentals for funerals. In the past, township residents did NOT pay to rent the social hall for a funeral dinner/memorial service. The decision was made to keep that the rule. Anyone not a resident of the township will pay regular social hall prices.
- A last minute resident complaint did not make it on the agenda, but we felt we needed to discuss it. Mark Coons made a formal complaint to the supervisors concerning a neighbor's trash being near or on his property in Croft. As there is a Property Maintenance Ordinance; a notice can be sent to the neighbor. But Mr. Coons property also does not meet the maintenance standards set by the ordinance. He will also receive a notice. Supervisors discussed renting a dumpster so the residents can clean up their properties. The supervisors are going to first have a conversation with Mr. Coons if he would like to pursue the issue.
