- LLC's Certificate of Organization and written authorization from the LLC's manager.
- Two checks and or money orders made payable to Goshen Township, \$20 Application Fee and \$80 Licensure Fee per guide. If Corporation, LLC, Partnership registers 5-8 guides, Licensure Fee is a flat \$400. **If applying for both Goshen and Lawrence Twp, the fees would double** *EX: Individual applying for both townships would \$20 Application fee and \$160 Licensure fee (\$80 per twp). A corporation, LLC or Partnership with 5 or more guides would be \$20 application fee and \$800 licensure fee (\$400 per twp) If less than 5 guides, it would \$80 per licensure*
